



### WINDOW WASHING

On <u>Tuesday</u>, <u>September 17</u>, <u>2023</u>, American Window Cleaning (Appearance Inc.) will be here for the quarterly cleaning of the exterior apartment windows at the Mauna Luan. We will post notices on the 1<sup>st</sup>, 3<sup>rd</sup> and 5<sup>th</sup> elevator landings in each building the week prior to this cleaning as a reminder to everyone. As before, on the day of your cleaning all plants will need to be removed from exterior planter boxes, and if you have screens blocking access to any of your windows, they will need to be removed also. Here is the tentative window washing schedule:

September 17-21 (Tuesday thru Saturday) weather permitting Tuesday 9/17 West A-E Wednesday 9/18 West F-L Thursday 9/19 East A-E Friday 9/20 East F-L Saturday 9/21 makeup day

## QUARTERLY PEST CONTROL

Kilauea Pest Control will be here on <u>Tuesday</u>, <u>September 24</u>, <u>2024</u> for their quarterly pest control treatment in the units that have contracts with them. The cost for this service is now \$220.00 per year/per unit or \$55.00 per treatment if you have it done on the regularly scheduled days. It will cost \$85.00 per treatment on any other day. If you are on this service please be sure that we have an Authorized Entry

form signed and in our possession if you will not be home when the technician arrives. If you are not on this service but would like to be, we do have contract forms available in the Management Office or on our website (maunaluan.com).

#### **NO-SMOKING RULES**

If this is you, we need to ask that you please stop using the stairwells and/or other places on the property to smoke. Signs have been posted around the property and we have asked that all smokers please help with this adjustment. PLEASE REMEMBER TO USE HEADLIGHTS AND OBSERVE SPEED LIMITS & ALL STOP SIGNS AT ALL TIMES WHILE IN THE PARKING STRUCTURE AND OTHER AREAS OF THE PREMISES! {USE OF HEADLIGHTS IS SO OTHERS CAN SEE YOU, NOT SO YOU CAN SEE!!} THIS IS ESPECIALLY IMPORTANT AT THE BOTTOM OF THE GARAGE RAMP! PLEASE NOTE: WHEN COMING UP THE RAMP YOU SHOULD YIELD AT EACH LEVEL TO VEHICLES COMING DOWN SO THEY DO NOT STOP AND BLOCK YOUR ABILITY TO MAKE THE TURN. MAHALO.

#### FEEDING FERAL ANIMALS

As you are probably aware, the Mauna Luan have House Rules on the issue of feeding of feral or stray animal (*House Rules Page 15, Section 3, Item G.- No feeding of wild or stray animals, or birds, is permitted anywhere in the common or limited common elements*) It has been reported of cat/dog food being laid out near the car wash area. This untreated food attracts all types of animals, cats, dogs, rodents and other pest. Management asks for residents not to leave pet food on the grounds, this is a pest issue and a violation ofour house rules. If anyone has questions on this policy please let us know. Mahalo!

# USE OF POOLS AND PROHIBITED ITEMS

We have been experiencing a much greater problem this year with noise coming from our pool areas. A portion of this can be attributed to larger numbers of people using the facilities. However, much of the noise is due to unusually loud screaming and yelling, especially in the evening hours. Please remember that you, as a resident host, are responsible for the conduct of your family and guests. If someone is getting a little louder than normal you should step in and ask them to try to hold the noise down. As reminders, the game of "Marco Polo" is not permitted due to the noise it generates; water guns/cannons may not be used in or around the pools; and, any child who is not toilettrained MUST wear swimming diapers while in any body of water. We understand that with water amenities such as ours the tendency to get loud is an easy one. However, everyone must also remember that you are not at a public pool where noise is not an issue. Our pools front the living units for 434 homes and most of what you do in the pools will be heard in these units. Daytime noise is usually expected and unless too loud, is not as much as a problem as the after dark noise. At that time most other residents are home trying to enjoy dinner and relax. Please think of this when using the pools. Mahalo.

## **Moving of Furniture and Use of Elevators**

A reminder that <u>no items of furniture</u> are permitted to be moved in any <u>unpadded</u> elevator. Big or small, anyone moving any item of furniture in an unpadded elevator is subject to a fine under our house rules. This prohibition also applies to *uncovered surfboards*. Surfboards need to be covered to help protect the elevator interiors from sharp edges. If you are not sure what you are moving is permitted, <u>please ask first</u> to ensure that you are not in violation of the house rules. Mahalo!
